## NOTICE TO ALL COMMERCIAL VENDORS

The Lincoln County Fair will be August 25th through August 27th, 2011. Set up day is Wednesday, August 24th, 2011 so that your booth will be ready when the Fair begins. Our theme this year is "Sew It, Grow It, Show It."

Cut-off date for your contract to be returned is July 22nd, 2011. If we do not receive your contract by this date we will assume you are not coming and if someone else has the same products and is ready to sign their contract they will be given the space.

Driving on the grounds to your booth must be done before 8:00 am each day. There is no driving on the grounds during the hours the Fair is open. Your booth will be open and manned during the hours the Fair is open, which are:

Thursday 9:00 am to 9:00pm

Friday 9:00 am to 10:00pm

Saturday 9:00 am to 10:00pm

**Sunday 9:00 am Vendors may leave**

**We do not allow silly string or products that make a mess of our Fairgrounds. We also do not allow fireworks, knives, lighters, cap guns or drugs to be sold on our Fairgrounds.**

Due to the small space, motor homes and trailers cannot be parked next to your vendor booth on the midway or the Fairgrounds

**NO DOGS ALLOWED ON GROUNDS!! If you bring a dog, it must stay in your vehicle—and not be tied up outside. NO EXCEPTIONS!!!**

NO REFUNDS - RAIN OR SHINE

You will receive two season passes with your booth. If you need passes for your workers, you will need to buy them.
