The lessee shall be responsible to return the facilities to the condition they were in or better.

4 - MERGER: it is understood and agreed that all understandings and agreements hereto for between the parties are merged in this contract, which along fully and completely expresses their agreement; and that the same is entered into after full investigation, neither party relying upon any statement or representation, not embodied in this contract made by the other.

5 - LIABILITY: The lessee agree to hold the Lincoln County Advisory Board, Lincoln County Fair and Lincoln County free and harmless of any liability, injury or damage to persons or property that may arise out of the use of the premises.

6 - INSURANCE: A certificate of insurance shall be mailed to the Fair Office 15 days before you use the arena.

7 - AMBULANCE: If the Davenport Ambulance and EMT's are required to be on the grounds, you will need to contact them 3 weeks in advance.
